

# Routt County Conservation District 3-Year Plan (2020 to 2023)

#### Overview

### **Organization of the Routt County Conservation District**

The Routt County Conservation District (RCCD) is a tax exempt, special purpose district authorized by, and organized under, Colorado Revised Statutes Section 35-70-101 et seq. (the "Colorado Soil Conservation Act" or the "Act").

### History

The West Routt County Conservation District was formed on December 7, 1942. A few years later the East Routt Soil Conservation District was formed on June 23, 1947. The two districts were merged in 1972 and renamed the Routt County Conservation District. The RCCD covers most of Routt County.

### **Function of the Routt County Conservation District**

RCCD was formed for the purpose of providing landowners with education and assistance in connection with conservation-related activities, including without limitation land stewardship, soil health, and water. The district partners with NRCS to identify local resource needs.

#### Mission of the Routt County Conservation District

To encourage stewardship of our natural resources which will ensure the preservation and sustainability of working landscapes through education, financial and technical assistance

#### **Trends Impacting Conservation in the Routt County Conservation District**

Lands within the District have experienced multi-year droughts in recent years. Additionally, significant growth in the County has been experienced. Impacts have been widespread extending to ag production; soil health issues; rangeland issues; needs for water management re-focus; watershed and forest health concerns; and others.

#### **Natural Resource Data:**

- Routt County covers 2,368 square miles in Northwest Colorado.
- Land Use: Rangeland = 730,000 acres, non-irrigated cropland/pasture = 86,000 acres, irrigated lands = 63,000 acres, woodlands = 535,000 acres, recreation = 47,000 acres & other = 55,000 acres.
- Land Ownership: federal = 775,000 acres, state and county = 69,000 acres and private = 672,000 acres.

#### **Natural Resource Priorities & Goals:**

The top three categories of focus for 2020-2023 have been identified as:

- Soil Health
- Water-related

Rangeland and Forestry

The District will assist landowners and local government agencies by providing programs and services related to the above resource categories.

#### Natural Resource Information /Education Priorities and Goals:

RCCD will host an Annual Landowners Meeting as well as Local Working Group meeting to discuss resource issues and seek input from landowners in the County. Education and outreach will include resources provided on the RCCD website as well as field days on pertinent topics.

#### **Staffing Needs:**

Currently RCCD has no employees. Until such time that sustainable funding sources can be established, this will likely remain the case. In the meantime, RCCD plans to partner with like organizations to fulfill its goals and objectives, as well as seek funding opportunities going forward.

#### **Conservation District Operational Goals & Objectives:**

- 1. Develop a professional grade website to use as a communication, education and resource tool.
- 2. Develop a communications plan to engage a larger group of landowners in our district.
- 3. Continually visit what value the district can provide.
- 4. Develop lasting partnerships with conservation-minded agencies and entities.

**Natural Resource Issue: SOIL HEALTH** 

Why is this issue a concern and what is the location: Soil Health is a pillar of Conservation Districts. A Soil Health initiative in Routt County is consistent with the Colorado Department of Agriculture state wide initiative to help gardeners, farmers and ranchers build drought resiliency, improve water quality, sequester carbon and reduce soil erosion through cost effective and sensible soil management practices.

<u>Three Year Goal(s)</u>: Define effective and efficient ways to support land owners and Ag producers in good soil health practices. Develop framework for feedback from producers in gardening, farming and ranching with technical service providers and others invested in agriculture and the health of our soils to build a program that will benefit Routt County Agriculture and Water Quality.

#### **Natural Resource Issue: WATER QUALITY and QUANTITY**

Why is this issue a concern and what is the location: There has been much activity on the water "front" in the Yampa Valley in recent years including healthy watershed implementation initiatives by the Upper Yampa River Watershed Group (UYWG) of its 2016 Watershed Plan; implementation of the Basin Implementation Plan by the Y/W/G Basin Roundtable (BRT); establishment of a large endowment to benefit the Yampa River titled the Yampa Water Fund; efforts to improve diversion infrastructure amplified by a first ever call on the Yampa to name a few. In the past, RCCD has been active in water issues and fills a distinctive niche due to its ability to work with land owners and ag producers as well as being part of a statewide network of conservation districts.

Three Year Goal(s): Work with land owners and ag producers to help them navigate the myriad of regulatory mandates; the multitude of water programs and agencies; and the potential sources of funding available to them to meet their water-related goals. Partner with other local, state and federal agencies and entities to maximize the value to landowners.
