Summary - We have paid Sharon and Big Horn Branding's GLCI expenses from our MVB account and have subsequently been reimbursed by USDA to cover those expenses. We

have not received any other GLCI-related funds. We have updated our MVB signing and access authority to remove Lyn and Cam and add Patrick, Kent, and Tom.

GLCI Account (separate from main Operating Account) i. Due to confusion at MVB caused by GLCI expenses being handled by both Cam and Kathy in the past, Kathy was removed from GLCI account. Future GLCI transactions will be handled by Tom.

Colorado PDPA - Notice of Assignment 1. On 6/6 and the RCCD board email received a notification from the Colorado Department of Regulatory Agencies w/ subject line "Colorado PDPA - Notice of Assignment"

It was a boilerplate notice that requested several actions including updating our name, address, banking details, and "official custodian" of RCCD monies, and communicating these details to the state and MVB.

A rep at the Banking Division in the Dept of Regulatory Agencies explained that the purpose of the email notification is to ensure adequate funds, above FDIC insurance levels, are available to state Conservation Districts and other entities.

We were able to respond via email with an updated RCCD address and confirmation that the treasurer is still the official financial custodian.

The email was received and acknowledged by the state.

A copy of the Notice of Assignment from the state was provided to Mountain Valley Bank Report accepted/approved; Sharon 1st, Ty 2nd

a. Virtual Fence Project Update:

Katherine Bedell requested \$22,000 for Coberly Creek collars; Virtual Fenc/GLCI Event to be conducted this Fall/September, details tba. NRCS is back supporting this program, but funding has been slow. Katheryn Bedell & Sharon Clever remain "on board with program & duties. Future reimbursement requests planned for Katheryn & Sharon, to expedite NRCS payments.

b. RCCD Scholarship Status:

FFA /4H or similar other scholarship program... with deadline by August meeting.
