Summary - A \$22,690 reimbursement from grant funds was deposited 7/18. These funds will cover the GLCI participant's collar expenditures. We received \$12,604.40 from the state support funding.

Insurer Requesting Confirmation of Equipment to be Covered

From July meeting: *Mountain West Insurance has contacted us on behalf of Hanover asking RCCD to review the list of equipment being insured. Their list includes the Vence*

Base Stations but does not include RCCD's 200 gallon Ag Equipment sprayer. The model and serial number were supplied to Hanover when we took out the equipment policy. I've asked Hanover to update the list to include the sprayer.

Current update: Mountain West had no record of our request to insure the sprayer. Cam forwarded an email thread with a Mountain West employee who has since left the company that requests coverage for the sprayer. It is now insured. I'm waiting to hear whether our rate will increase.

Alternative to Field Day on ranch site on 10/5 or 10/7, discussed potential of hosting 30 minute event at Mountain

Valley Bank conference room, 10/21, during or after RCCD Board meeting... host online e-fence/operations examples. Vence could be invited to offer continental/donut breakfast to producers to participate-

Halter brand collar systems being considered as alternative to Vence brand, by Yampa Valley Ranch, Chase Hall/Randy /Rowe...
